

# ICRS Online Profile: Terms of Use

These terms cover the use of the Online Profile Service provided by **ICRS - International Cartilage Regeneration & Joint Preservation Society** (hereinafter referred to as "ICRS"), including the use of data gathered during the use of this service. By creating and using your Online Profile and accepting these terms of use, we consider that you are in agreement with these terms.
2. After creating your Online Profile and accepting these terms of use, you will be sent an activation link that will allow you to activate the Online Profile.

ICRS will gather and process the data submitted by you when using one of the features of the Online Profile and/or the data required to enable you to use the Online Profile (e.g. personal data, non-personal data and information). ICRS also reserves the right to transmit address data to SAGE to process the Journal "Cartilage" mailing & shipping. 4. The use of your personal information is based on our "legitimate interest" in providing you with additional information and direct advertising about our services (under Article 6 sec. 1 sent. 1 lit. f, sec. 4 of the GDPR regulations).
